

Veterans Affairs (VA) Education Benefits Shopping Sheet

For students participating in a Federal GI Bill® program, you may qualify for financial assistance to help cover the costs of your Tuition and Fees. Students using Chapter 30: Montgomery GI Bill® (MGIB), Chapter 1606: Montgomery GI Bill-Select Reserve (MGIB-SR), and Chapter 35: Dependents Education Assistance DEA) are financially responsible for all charges as these GI Bills® does not cover the cost of attendance. However, students utilizing Chapter 33: Post 9/11 GI Bill® are eligible for financial assistance as this program does pay tuition and fees based on the student's eligibility.

Below are two charts explaining coverage of tuition and fees for students utilizing the Post 9/11 GI Bill® for both Undergraduate (UG) and Graduate (GR) students.

Per VA regulations, the Post 9/11 GI Bill® <u>does not</u> cover the costs affiliated with: non-resident tuition, parking permits/tickets, dining plans, athletic tickets, room & board, and non-degree applicable courses. These items are the financial responsibility of the student. Additionally, all External Scholarships earmarked for "tuition only" will be deducted from the total amount billable to the Department of Veterans Affairs.
